GUIDE TO AUTHORS

The Journal of Ayub Medical College (JAMC) is a biannually journal edited and published by the Ayub Medical College. It introduces research progress made in the medical and health sciences in the country for better communication among doctors and researchers. Papers are accepted in English with the understanding that the work described is original and not being or already submitted for publication elsewhere. Each manuscript will be screened by the editorial board or by the advisory panel. Accepted manuscripts will be published without charge or remuneration.

Manuscripts: An original manuscript and one copy should be submitted to the editor along with the names of all authors including their highest academic degree(s), name of the department and institution from which the work originated. The transmittal letter should designate one author as correspondent and include his/her complete address. Manuscript should be typed double-spaced on A4 (or 22 x 30 cm) fine paper with at least one inch margins, pages should be numbered. Manuscripts should conform to conventional structure: first the title; then the names of authors with address: text (consisting of an introduction, material and methods, results and discussion for original articles); acknowledgements, etc; and lastly references.

Abstract: A concise abstract of approximately 200 words of the article should be typed on a separate sheet describing the major observations.

Running Title: A running title of 50 letters or less is required.

Tables: To be typed on separate sheet(s). Each should have a title.

Figures: One separate sheet(s). Each illustration (photographs, graphs, line

drawings, charts and tracings) should be of sufficient size to allow reduction to half-size. Only illustration that increases the understanding of the text should be included. The photographs should be glossy prints in sharp focus. Each figure must be labelled and should have a title. The editor reserves the right to limit the number of illustrations and to mask out the eyes in case of patients where written permission is not accompanied.

Measurements Units: Metric system units should be used.

Abbreviations: Abbreviations should be spelled out initially when first used in the text with the abbreviation in parenthesis. It is preferable to use universally understood abbreviations.

References: All references cited in the text must be listed in numerical order. They should be typed on separate sheet. Use the index medicus style for the abbreviation of journal for the punctuations of references. List all authors if they are five or less; for six or more authors, list the first three followed by et al.

Examples:

Journal Article: Khaliq, M.A. Khan. J.A. and Shaheen, P. Bacteriological study of Drinking water in Abbottabad. Pak. J. Med. Res. 1986; 25: 96-99.

Books: Lewis, M.H.R. Muscular Dystrophy, London: Churchill-Livingstone., 1973.

Chapter in Book: Woessner, J.F. Lysosomal Function. In: Lysosomes in Biology and Pathology (Dingle, J.T. and Fell, H.G. ed.), 1969; 1: 299-329, North-Holland Publishing Co., London.

Proofs: The author will receive a proof of his/her paper prior to printing.
