Radio / TV Programs. Radio / TV Talk Shows on Anti-Corruption Theme including FM, Pakhtunkhwa Radio Channel in consultation with Information Department Khyber Pakhtunkhwa (Action by Information Department Khyber Pakhtunkhwa).

Banners / Posters. All Provincial Govt: Departments are directed to display banners / posters in front of their offices (All Administrative / Attached Departments).

- 3 - Slogans in Urdu and English should be chosen as per list provided.





Subject: Awareness Plan -- Anti -Corruption Week – 2nd Dec. to 09th Dec, 2024

Honourable Sir,

السلام علیکم

International Anti-Corruption Day is commemorated every year on 9th December; on the Day UNCAC (United Nations Convention Against Corruption) was put to signatures in Mexico and Pakistan being part of its Executive Committee amongst first few other countries signed and ratified it. Through this convention, Nations States including Pakistan have taken many strides to fight against Corruption & Corrupt Practices. Pakistan Tehreek-e-Insaf (PTI) Party Manifesto lays greater emphasis on Accountability, Rule of Law and Justice through upholding social contract made with public through the Constitution of Pakistan ensuring the philosophy of balance through trichotomy of power.

2. The Chief Minister of Khyber Pakhtunkhwa has set his various forcegoals of good governance including strengthening of Anti-Corruption Regime as a foremost Important Issue. It includes creating awareness against corruption, reforming departments and institutions through reduction of opportunities of corruption and corrupt practices and strengthening Anti-Corruption Establishment (ACE) by improving its rules, Act and Induction of requisite desired manpower to investigate white-collar crimes cases with due diligence, prudence and effectiveness without creating any harass and commotion. On the other end Chairman PTI has set a watchdog body named PTI Internal Accountability Committee to oversee the aspects of anti-corruption pertaining to corruption and corrupt practice within the ranks and files of the Party including elected representatives.

3. To commemorate the day in a most befitting manner and set goals for future, the Chief Minister has instructed that all departments/administrative setups / autonomous and semi-autonomous bodies shall execute Awareness Plan as per these orders.

4. The activities are to be planned as under and post reports be prepared and sent to the Office of Advisor to Chief Minister on Anti-Corruption as soon as possible but not later than 20th December 2024 for furtherance of drive through Annual Awareness Plan being Issued by end December 2024.

a. Commissionerate / District Level Activities

- (i) On receipt of these instructions all Commissioners should hold a coordination meeting for activities in their respective districts and areas of jurisdiction.
- (ii) Public Representative be also Involved Including MPAs/MNAs, District & Tehsil Nazims.
- (iii) Activities at the district level should be coordinated and maximum participation from people from different walks of life, including students be ensured.
- (iv) District-level seminars followed by walk to be arranged in each district during the week culminating on 9th December 2024.
- (v) Billboard and Road Side / Central Boards with meaningful messages in National and Local Languages only be displayed during this period. (English slogans be avoided)
- (vi) Renowned speakers/educationists and motivational speakers be arranged at all Universities and College levels to address the students on ill effects of corruption and corrupt practices.

(vii) A pledge of commitment be administered at the end of seminar/lecture/motivation speech involving the public at large: -

(viii) **Seminars of Public at Large**

(x) All DCOs will arrange seminars/lectures in coordination with DEOs in each Higher Secondary School / Degree Colleges and Universities in their area of jurisdiction. Public Representatives, notables and parents must be involved.

(xi) Banners in each office with a slogans والمرتشی فی النار be affixed alongside preparation of stickers for Cars/motor vehicles. Volunteers' students be provided with stickers to affix on transport / vehicles.

(xii) Special Walks other than at the end of each seminar/lecture must also be conducted on the sides of the main roads without interrupting the traffic flow.

(xiii) Local Radio Programmes

(xiv) Races and Walks involving public at large through NGOs.

(xv) Involve NGOs and volunteers to shape up the programmes pertaining to character building and awareness against corruption.

(xvi) All activities be ensured with Media Coverage.

b. **Departments and Autonomous Bodies / Organizations:** These setups including those mentioned at para 4a ante will also ensure the following: -

(i) Banners and standing boards with appropriate slogans are displayed at prominent places for duration of mentioned dates.

(ii) Websites and other portals pertaining the organizations are inserted with slogans.

(iii) The slogans adopted by Khyber Pakhtunkhwa Government be affixed on every advertisement in print and electronic media as a permanent practice.

(iv) Pep Talks by the Heads on various aspects of malpractices prevalling in their setups and introspective approach for correction.

(v) Slogans on Permanent Basis to be affixed are suggested below: -

(vi) **Morning Assembly:** - All Officers Incharge of a particular setup of Government Offices shall ensure morning assembly of ten minutes including all ranks and file at an appropriate time during whole length of year. Recitation from Holy Quran with translation and a pep talk on any appropriate issue and matter effecting like safety, health, welfare, conduct etc. be made.

c. **Information Department:** Ensure the following: -

- Plan a comprehensive campaign on awareness through electronic, print media and advertisement companies.
- Billboards, center boards in all major cities of Khyber Pakhtunkhwa carrying various slogans.
- Arrange seminars on 9th December at Nishtar Hall in coordination with this Office.
- Special Page on Anti-Corruption in print media in Urdu only.
- Public messages through telcos.
- Programmes on FM Radios.
- Any other effort to commemorate the week in a most befitting manner.

d. **Higher Education Department:** Issue instructions for various activities mentioned in this paper alongside others based on previous experiences and record.

- Seminar by each University during the week followed by walk with due media coverage.
- Ministers / Advisors and Public Representative be invited by the Universities alongside educationists and learned media representatives, retired/serving bureaucrats.
- Various steps mentioned at para '4a' ante pertaining to students shall also be ensured.
- Issue instructions by 20th November 2024 at the latest for providing time space for preparation.

e. **Elementary & Secondary Education Department:** At School / Elementary College level activities should be aimed at character building of future leadership. Instructions be issued to hold school assemblies with topics pertaining to reknown Muslim leaders highlighting their character traits and achievements. Walks and gathering involving Teachers Parents committees and notables of the area. Issue instructions by 20th November 2024 at the latest for providing time space for preparation.

f. **Slogans Adopted** Following slogans are adopted by the Government on permanent basis and must be sparingly utilized to create awareness amongst public at large and also amongst public servants.

(a) Urdu

These slogans be used as a caption on top of each letter/correspondence as decided by the Head of the concerned setup.

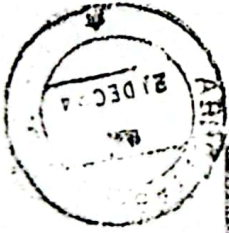
